

Minutes of Cedarville Village Council

Held January 28, 2019

Council met in regular session on January 28, 2019 with Councilman Pro-Tem Pergram presiding. Council members present were Brooks, Chisholm, Pergram, Stancliff, Terrell, and Ware. The Fiscal Officer recorded the minutes.

Minutes: Minutes of the January 14, 2019 meeting were accepted as submitted.

Mayor: Excused

Mr. Andrew Wonders – representing the Park Committee – made a presentation regarding plans for the Community Park and asked Council to consider using some of the Greene County Grant funds for this. Plans (needing funding) include:

- A ‘centerpiece’ ride or equipment,
- Replacing the two swing sets

The committee has also approached Greene County Parks and Recreation for another grant. Community Block Development Grants are available – but the Village has not qualified for these in the past. The Community Relations Community will meet with the Park Committee and make a recommendation to Council.

Police Chief:

- Applied for a grant for new vests for all officers – waiting to hear from them.
- Waiting for County Building to approve the permit for continued work at the police station
- New World software still pending; may have to wait until relocated in new offices
- \$636 was released from the evidence room (by judge) as well as other items that have been there for a very long time.
- The new employee policy handbook is in final edit.

Village Administrator:

- The truck/plow had to be repaired. A new truck may take six (6) months to obtain after ordering.
- Have called ODOT – again – about pot holes. ODOT says they were here and fixed them; however they missed several and the patching they did has already come out.
- EPA reports are completed and submitted
- Several (ash) trees at the park are dead and/or dying. These will have to be removed by a contractor as they are more than the Village employees can handle.
