# Held April 13, 2020

## Mayor Pergram:

- County has notified Village of potential shortfall in tax revenues due to COVID-19 shortfalls up to \$70,000 possible. Mayor has requested that department managers save 10% of their budget this year.
- Greene County Park still open

#### Police Chief Combs:

- 416 calls since 3/23/20.
- PPE has been provided for officers N95 masks, gloves, sanitizer, as well as procedures for shift change, vehicle change, etc.
- Officers responding to critical care calls only; remaining calls being taken by phone.
- Officer Lovely has resigned / separated.
- C. Kellum (PT officer) is now FT with National Guard. Procedures prevent him from working as a police officer while with the Guard. Chief Combs working to address this.
- 30 COVID-19 cases in Greene County; not aware of any confirmed cases within Cedarville.

#### Village Administrator Furay:

- The administration offices are closed though road/utility employees continuing to work. Attempting to be compliant with health department/CDC guidelines. Department has PPE for employees.
- Mr. Frank Fouts has been laid off at his request.
- Someone ran over the stop sign at Orr St.
- Work at Cedar Park ongoing
- Cleaning out street drains due to the recent heavy rains.
