Minutes of Cedarville Village Council

Held April 8, 2019

Council met in regular session on April 8, 2019 with Mayor Pergram presiding. Council members present were Brooks, Chisholm, Pergram, Stancliff, Terrell, and Ware. The Fiscal Officer recorded the minutes.

Minutes: Minutes of the March 25, 2019 meeting were accepted as submitted.

Mayor Pergram:

- Mayor expressed his appreciation for Officer Holmes' many years of service to the Village will have a public celebration soon.
- Mayor also made recommendation to the Council that Officer Holmes be allowed to keep his duty weapon a common practice for officers with long-term service.

Mr. Stancliff moved and Mr. Brooks seconded to approve Mayor's recommendation to hire Mr. Combs as the Village police chief. Motion passed with all ayes.

- ODOT scheduled to be starting work "soon".
- ADA-accessible ramps are being installed throughout town.
