Held April 26, 2021

Council met in regular session on April 26, 2021 with Mayor Pergram presiding. Council members present were Brooks, Chisholm, Dawes, Stancliff, Terrell, and Ware.

Mayor Pergram:

• Mr. and Mrs. Beuttell are present and request that lots at 7 and 9 School St. be rezoned. They are currently attempting to buy this property but, as it is currently zoned "light industrial", they cannot get financing. ("Light Industrial" means that, in the event the house is destroyed via "Act of God", fire, etc., the house cannot be replaced.)

Mr. Brooks moved and Mr. Dawes seconded to authorize the zoning administrator to write a letter to Mr. and Mrs. Buetell stating Council's intent to re-zone this property to residential. Action to be taken at a future meeting. Motion passed with all ayes.

- Two new PT police officers have been sworn in.
- May 8 from 6:00-7:00, the CHS jazz band will be performing outside the Opera House.
- Handbook review continued with Council reviewing leave for donated sick pay and for bereavement leave.

Police Chief Combs:

- Officer Whitby saved a life by recognizing carbon monoxide in a home and calling fire department to verify with their "sniffer" before allowing a resident back into her house.
- Successful drug take-back held April 24, 2021.
