Minutes of Cedarville Village Council

Held August 26, 2019

Council met in regular session on August 26, 2019 with Mayor Pergram presiding. Council members present were Brooks, Chisholm, Dawes, Stancliff, Terrell and Ware. Councilmember Brooks recorded the minutes.

Minutes: Minutes of the August 12, 2019 meeting were accepted as submitted.

Mayor Pergram:

- Mayor discussed recommended changes to obtaining a solicitation permit. This will be updated.
- Discussion regarding phone expenses at Village offices and police station.
- Parking issues in town: Landlords must provide <u>off-street</u> parking. Zoning administrator to send letter to 64 Church St. and any others regarding parking laws.
- Grace Church parking lot interest in vacation alley and allowing Grace Baptist Church to pave and use. Further action pending.
- A prescription drug drop-off will be held at Cedar Care Pharmacy on Oct 26 from 10:00 a.m. through 2:00 p.m.
- CedarFest 3 police vehicles will be in the parade. Council members able to ride in parade as well.

Police Chief Combs:

• Chief Combs presented Officer Jayson Ruth with recommendation to hire as FT Police Officer. (Officer Ruth currently a PT officer for the Village and a Village resident).

Mr. Dawes moved and Mr. Stancliff seconded to approve the hiring of Officer Ruth as a FT police officer. Motion passed with all ayes.

- Chief noted several handbook updates and ordinance updates that need to be updated.
- Going forward, PT officers will be hired as auxiliary officers (without pay / benefits) until all training is completed.
- Chief noted that several officers are in need of winter coats before the season arrives.

Village Administrator Furay:

- Working on preparations for CedarFest.
- Remaining parking spots have been painted.
- Additional mowing notices have been sent out.
- Bridge inspection being scheduled.
- Will sell old vehicles (for more than scrap value) at CedarFest.
- Will return to street work issues after CedarFest.
